9. GSA Executive Report

9.1.President's Report

He started with saying that in the last president executive meeting, the Dean of CGPS informed that this academic year the university allocated 100 case for the paid maternity allowance, and that the announcement will go in the December. He hoped that this would bring a positive change among the graduate students who are expecting, specially for the international students. Then he also mentioned about hiring new full time office manager who joined GSA at September 26th. He asked everyone to be patient with him as he is going through some training.

9.2. Vice President Finance and Operations Report.

He began by updating members that the GSA fall bursary application began from October 16th and the deadline for this is until November 16th. After the application deadline, each of the application would be evaluated. He asked if any council members are interested to join the bursary committee, they should send an email to the GSA Chair showing interest. This time CGPS is also contributing, so they have a good number of money for the bursary. Also this time they have special section for students who are pregnant. He also announced about hiring new GSA coordinator. They were planning to hire 3 coordinators, because sometimes there are some events in the weekend/holiday. The executive team would help in this hiring process and it would start in the coming week. He also announced about hiring new office manager who completed his phd in public policy in the UofS. 9.3. Vice President Academic and Student Affairs Report.

She has been actively involved in various initiatives. She mentioned that during their tenureship they received some academic misconduct and plagiarism related issues for grad students. So, they were really concerned about that and were trying to improve the awareness. So, she and the USSU Academic affairs worked with Susan Bens, Academic Integrity Strategist, regarding this. They planned to sit for it on a regular basis. Furthermore, they are also trying to improve the structures like how the new AI tools are used, also the awareness related to it and others. She also said that she communicated with the graduate academic affairs committee about improving the policy of the academic integrity online course. She mentioned about arranging event with the ISSAC and other departments in the university to improve awareness. Lastly, she talked about taking new role as the chair of the diversity committee. She was keen on sharing ideas and promoting awareness on a wide range of diversity-related topics. She encouraged people to nominate themselves or their friends as a member of the diversity committee and she was looking forward to organizing some exciting events from this committee.

9.4 Vice President, External Affairs Report.

He was not present at the meeting. President Mostofa said on his behalf that if any council members have any questions for the VP External Affairs, they can be directed to his email address at gsa.external@usask.ca at any time.

9.5 Vice president Indigenous Engagement

VP Indigenous was not present during the meeting. President Mostofa updated on her behalf about recruiting a Vice Provost in the indigenous engagement. There were three shortlisted candidates and all the executives had the opportunity to meet all of the candidates. They were asked about their background, and their motivation for this position, also what positive changes they would bring at the U of S. Based on the meeting, the GSA sent feedback to the hiring committee about all three candidates. The VP Indigenous Engagement played a very active role on that meet & greet.

10. Other Business

The president informed that he had meetings with faith leaders and student wellness center regarding the holiday hangout. They showed their interest to collaborate with GSA. So, they decided to organize the holiday hangout for four consecutive days starting from December 27th to 30th, which would create good networking opportunities among the students.

Also, he mentioned about the National Day of Action, which is a movement led by the Canadian Federation of Students, would happen in November 2023. The goal of that campaign would be to fight the fee and make post-secondary education free. A training, organized by the Canadian Federation of Students at the University of Regina, was attended by the President, VP finance and the chair of the GSA. The training was to make the campaign successful and they also provided the materials like all the posters and the souvenirs. So, he asked all the council members to join for the National Day of Action and make the movement successful. Lastly, he mentioned that if any members have any feedback regarding this, they could share their opinion.

The GSA president informed council members that the GSA Executive election procedure is posted on the GSA website, so members are encouraged to visit the website for any information. Next council meeting will be sent.

GSA President's Report (October - November 2023) to GSA Council Members

Dear GSA Council Members,

Please find the GSA President's monthly activity summary from October 15, 2023, to November 11, 2023, as listed below in order of importance of the activities.

1. University of Saskatchewan Senate Meeting (November 4, 2023)

The GSA president presented GSA's half-yearly activity report (available HERE) to the University of Saskatchewan Senate meeting on November 4, 2023. GSA presidents discussed GSA's past events and provided information about upcoming events. Further, the GSA president discussed GSA's ongoing advocacy priorities and planned service expansion. The GSA president also requested senators to advocate for the local, provincial, and federal governments to allocate more funding for post-secondary education.

2. PEC/GSA Executives monthly meeting (November 2, 2023)

The GSA executives discussed the following two issues with the President's Executive Team.

- I. Part-time graduate study opportunities coupled with part-time tuition fee options for part-time students.
- II. Chronic Electricity Outage Problem at the Souris Hall at the McEown Park Residential Area

3. GSA Executives by-weekly meeting (November 1, 2023)

- I. GSA Coordinator Hiring
- II. GSA Research Conference 2023

4. Fall Convocation (November 8, 2023)

The GSA president attended the Chancellor's Platform Party of the Fall 2023 Convocation to celebrate graduate students' accomplishments.

5. National Day of Action (November 8, 2023)

On November 8, 2023, students from post-secondary institutions across Canada marched for the

National Day of Action campaign under the leadership of the Canadian Federation of Students (CFS), demanding Free and Accessible Post Secondary Education. The campaign's objective was to demand the Government of Canada to prioritize accessible education for all. The University of Saskatchewan GSA strongly supported the movement and organized a march on November 8, 2023, from 11:45 pm to 12:45 pm here at the University of Saskatchewan.



6. GSA Executive Team meeting with USASK Faculty Association External Relations Committee

The GSA executive team meets with the USASK Faculty Association External Relations Committee each term. This meeting aims to inform the faculty association about GSA's ongoing advocacy work and request their support on various university committees. For example, GSA advocates for paid parental leave for thesis-based graduate program students. So, GSA expects the faculty association to endorse our advocacy work and request acceptance. The GSA executive discussed the following advocacy priorities for the 2023-2024 Fiscal year and invited all council members to save a copy of this list so that GSA academic council members can advocate each of these issues in their respective department's faculty council. GSA Advocacy Priorities for the 2023-2024 Fiscal Year:

- I. To advocate for a minimum guaranteed funding for all thesis-based graduate students not less than the equivalent of Saskatchewan's minimum wage salary.
- II. To advocate ensuring a university-wide minimum guaranteed scholarship/stipend for thesis-based graduate students for a duration compatible with the median degree completion time of the

University of Saskatchewan graduates.

- III. Advocacy for the introduction of a universal "Parental Leave Bursary" for graduate students like other U15 universities. For example, the University of Waterloo offers an eight-month Parental Leave Bursary (including adoption) to eligible graduate students. Details can be found HERE.
- IV. Advocacy for the introduction of walk-in clinic service at the student wellness center.
- V. Advocacy for the introduction of part-time study opportunities coupled with part-time tuition fee options for part-time students.
- VI. Advocacy for the removal of international tuition differential for master's students.
- VII. Advocacy for a seat on the University of Saskatchewan Board of Governors.
- VIII. Expanding the anti-racism and anti-oppression training beyond top-level university leaders, especially for faculty members, managers, and directors of different university services.
- IX. Advocacy for broader and faster adoption of Equity, Diversity, and Inclusion (EDI) principles across the university.

11. Election of new Council Chair, Vice Chair, and Recording Secretary

The GSA elected its Council Chair, Vice Chair, and Recording Secretary at the October 18, 2023 council meeting. The GSA president served as the election commissioner as the GSA council chair herself was a candidate for the Council Chair position.

12. GSA Holiday Hangout Event (December 27, 28, 29, and 30, 2023)

The GSA organized a very successful holiday hangout event on December 28, 2022. The holiday hangout was open to all graduate students. Two hundred fifty graduate students attended the event. Because of 99 occupancy limits at a time at the GSA commons, the event was split into two sessions: 1) 10 am to 2 pm and 2) 3 pm to 8 pm. Snacks, lunch, and dinner were provided among all graduate students. Students participated in many indoor games, including Uno, monopoly, dart board, carom, etc. Students highly appreciate the event and sincerely requested to continue organizing the Holiday Hangout event during the long holiday break of Christmas 2023 and New Year 2024. Thus, the GSA plans to organize the 2023 Holiday Hangout event for four days, December 27, 28, 29, and 30, during the 2023 holiday session in partnership with the University of Saskatchewan Faith Leaders Council and Student Wellness Centre. The GSA plans to keep the GSA Commons open from 1 pm to 9 pm each day and provide all attendees late afternoon snacks and dinner. Like the 2022 Holiday Hangout events, students will have opportunities to participate in various indoor games listed above.

13. Governance Committee Meeting (December 6, 2022)

The GSA president attended the Governance Committee Meeting and discussed policies about graduate student representatives to the department faculty council. The GSA president insisted that the department's graduate representative to the faculty council should be nominated by the elected representative of each department's student association, not the department's chair/head.

14. Search Committee Member for the University of Saskatchewan CGPS Associate Dean (November 6, 2023)

The GSA president serves as a search committee member for the Associate Dean of the University of Saskatchewan's College of Graduate and Post-Doctoral Studies. The GSA President attended the meeting on November 6, 2023, and contributed to the discussion.

15. GSA Meet & Greet with reps from A&S Dean's Office (October 30, 2023)

The GSA executives met with the newly appointed dean of Arts and Science, Professor Brooke Milne, and discussed GSA's list of advocacy and priorities for the 2023-2024 fiscal year. The GSA executive specifically requested the dean to increase graduate student funding for thesis-based programs and implement universal paid parental leave (including adoption). The GSA executives also requested to bring down International Masters student tuition to a domestic level similar to that of Ph.D. students.

16. Monthly meeting GSA Executive/Vice-Provost, Students and Learning (October 25, 2023)

The GSA executives met the newly appointed Vice Provost of Teaching and Learning, Professor Jerome Cranston, and discussed the following issues:

The GSA President met with Rita Hanoski and Jocelyn Orb of the Student Wellness Centre to discuss jointly organizing the Holiday Hangout event 2023. Although the GSA initially planned to organize the 2023 Holiday Hangout event for two days, the GSA decided to extend the event for four days, provided that the Student Wellness Centre will provide financial assistance for two more days. The student wellness center also agreed to offer three volunteers each day to coordinate the event.

The GSA, in partnership with the Huskies Cricket Club, is scheduled to organize the World Cup Cricket 2023 final match watch party for graduate students on November 19, 2023, at the GSA Commons. The watch party will be open to all University of Saskatchewan graduate students. The GSA will sponsor the food and drink for the attendees.
