#### **Social Club Ratification**

- Tox on tap No representative to speak.
- Huskies Cricket club

The presenter, an undergraduate student representing the newly established Huskies Cricket Club from the Universities Science department, addressed the audience. He highlighted the growing popularity of cricket worldwide and its increasing presence in Saskatoon. Urgently, the social club aims to introduce a university cricket team similar to the Huskies football club. To do this, they seek approval to compete with other universities across Canada and intend to organize indoor cricket leagues for students. The presenter mentioned that they have already formed the committee for the Huskies Cricket Club, established banking channels, and are now actively seeking sponsors to host an Indoor Cricket League for University of Saskatchewan students. They are currently awaiting sponsorship confirmation to seek permission from the University's gymnasium to host the inaugural indoor cricket league, hence their request for approval from the GSA.

#### **Questions and Responses**

Q: Is it a graduate student club or an undergraduate student club? R: It to both. We have a composition of 75% graduate students and 25% undergraduate students in the club.

Q: A GSA member asked the fraction of executive members of the club since the constitution makes provision for at least 50% of graduate students as part of the executives of the club to qualify for ratification.

R: In response, he shared that exactly 71.34% of the executive committee are graduate students, while the remaining members are undergraduates.

Q: As part of the athletic events on campus, has the committee reached out to the athletic department of the University to inquire from the Huskie manager? R: The athletic department expressed enthusiasm about having a cricket club but advised that the club needs to be ratified first before applying for recognition as the Huskies cricket club.

Q: How many members are in the club currently, and again, what fraction of the executives and members are graduate students?

R: The representative reported that we currently have a 7-member executive committee, with five (5) being graduate students. We have a total of one hundred and fifty (150) members, with over 60 being graduate students.

Q: Is there a strategy to enrol more graduate students? R: We have identified some graduate students in the club who can help guide the undergraduate members. Since the undergraduates are particularly keen on both indoor and outdoor sports, they form a significant portion of our membership.

Q: Is there a specific location where you have planned to play? R: Yes, there are already designated cricket grounds at Edison, 33rd Street, West.

### **Nepalese students Association**

Deepa Sabethi, a graduate student in the Department of Electrical and Computer Engineering at USASK, introduced herself as the representative of the Nepalese Student Association. She emphasized that the association comprises students from NEPEL at USASK and serves as a vital support network for both graduate and undergraduate students, while also promoting Nepalese culture at the University of Saskatchewan. Their assistance begins right from the application process to the students' arrival at the university. Their inaugural general meeting took place on July 20, 2023. Deepa mentioned that there is a newly formed committee, and the group received ratification last year. They have submitted all necessary documents including their constitution, void cheque, and form. They are seeking re-ratification from GSA, as they have 68% graduate students and 32% undergraduate students, with all executive positions held by graduate students. Hence, they kindly request GSA to re-ratify the association.

# **Questions and Responses**

Q: Why are you requesting re-ratification? R: While she agrees, she wants to clarify that they are seeking re-ratification due to the recent appointment of new executives for the 2023-2024 academic year.

Q: How many individuals do you represent? R: Approximately 48.

Q: Have all the new executive members completed their registration? R: Yes, they have all completed their registration.

#### 3.0. GSA Executive Report

#### 3.1 President's Report - GSA manager hiring update and others

The GSA president provided an update on the application process. Out of the 15 received, the committee shortlisted 5 candidates based on the highest nominations. These individuals underwent interviews conducted by the 7-member committee. Despite one committee member being unavailable, all seven essential questions were asked. Following the interviews, two candidates emerged as qualifiers. As a result, a second interview will be held to select the final candidate for the manager position, scheduled for this upcoming Friday on September 15, 2023. The new manager is set to commence duties on September 18, 2023.

Furthermore, on September 6, 2023, they met with President Peter Stewardship and his team to outline their advocacy priorities for the year. The president encouraged members to bring forth their recommendations for further advocacy efforts, both within and outside the University administration. Additionally, they announced plans to meet with representatives from the provincial government, the city mayor, and the education minister. Therefore, all submissions and recommendations are welcomed for this endeavour.

Regarding the childcare issue, he shared that there have been several meetings involving the Dean, CTPS, and the USSU manager. They are actively working on the necessary groundwork and are hopeful for a positive outcome. There is also a scheduled meeting with the University president, and thus far, the university has shown great cooperation and support. The Dean of CPTS has not only expressed willingness to serve as a mentor but also to actively participate in addressing the challenges faced by graduate students, particularly those with children. She has agreed to join them in discussions with the president, and the president is also on board. Additionally, during a meeting with the USSU, it was noted that all day care center structures were constructed by the university. Therefore, when the executives meet with the president, they are optimistic about receiving similar support.

#### **Questions and Responses**

Q: Will the new research communication workshop include an advanced speech component, or will it be integrated with the 3-minute thesis? Or will there be a separate workshop to assist with the 3-minute presentation? Is this a completely new initiative?

R: The research communication workshop and the 3-minute thesis event are distinct. The workshop will offer a comprehensive approach covering a broader range of communication skills. While there was a request for financial support from GDPS for the 3-minute event, it was unfortunately declined. However, there is encouragement to explore alternative sponsorship opportunities. The executive is still eager to launch this program.

#### 3.2 Vice President Finance and Operations Report.

He began by updating members on the GSA spring and summer bursary program. Following two calls for applications, they received a total of 33 submissions. Ultimately, all 18 applicants were granted the bursaries, and the results were officially announced on August 15, 2023. Currently, there is a budget of 90,000 allocated for the upcoming two rounds, covering both the fall and winter terms. Additionally, the GSA commons and operations area has seen a rise in activity, with a daily barbecue setup. There is an ongoing inquiry about the possibility of the president offering more bursaries, especially given the increasing number of graduate students. He also mentioned engagements with the PPC, ISSAC, and off-campus meetings with the city of Saskatoon. #### **Questions and Responses**

Q: What is the composition of the bursary committee?

• R: There are five of us in, consisting of myself, the VP of Student Affairs, the VP of Academics and Student Affairs, two council members, and the CA. The final person is a dedicated volunteer.

• Two executives, two council members, and one representative from the general student body make up our team.

The GSA president emphasized the existence of eight standing committees, including the bursary committee, each comprising nine members, operating in accordance with established regulations. Furthermore, he emphasized that these committees are open to anyone interested in participating.

#### 3.3. Vice President Academic and Student Affairs Report.

She has been actively involved in various initiatives. This includes organizing an orientation for new graduate students, with a detailed report submitted. She's collaborated closely with the VP Finance on both the bursary and hiring committees. Additionally, the president mentioned her work on two ratification processes and an academic council ratification process.

Furthermore, she recently participated in a meeting with the VP Indigenous. From three candidates, two have been shortlisted, and interviews for the remaining candidate will be conducted next week. Her involvement with the USSU Academic Vice President has revolved around addressing the rising concerns of academic indiscipline, particularly among international students who come from diverse educational backgrounds.

Additionally, she holds the position of Chairperson for the Diversity Committee. She is keen on sharing ideas and promoting awareness on a wide range of diversity-related topics. Moreover, there are plans to establish a GSA Diversity Committee soon. These initiatives reflect her commitment to fostering inclusivity and understanding within the graduate student community. Thank you.

#### 3.4 Vice President, External Affairs Report.

They are actively engaged in discussions with the Saskatchewan government to address pertinent issues facing graduate students, particularly in terms of funding. They are optimistic that these matters will receive proper attention by September 7th, 2023. A proposal is in the works to present to the government of Saskatchewan, and they welcome input and suggestions from all members.

In addition, they are in the process of identifying a suitable venue for the next summer games. One location under consideration is the **TCL Marku** Hall at Saskatoon Holiday Inn. They are open to receiving recommendations and comments from members regarding potential venues that would ensure the success of these events. #### 3.5. Vice president indigenous Engagement

She began by acknowledging the recent busyness with the powwow, various hiring committees, and other events. She informed the council that September would host Truth and Reconciliation Day, extending it into a week of reflection. She encouraged all council members to wear orange from September 22nd, 2023, onward to symbolize the significance of the week and contemplate Canada's true history. Numerous activities are planned from the 22nd to the 30th. Additionally, she mentioned an event on September 25th from 11:30 to 1 pm at the Gordon Oakes Center, where lunch will be provided. Another event, the blanket project launch in the Murray Library, is scheduled for Wednesday, September 20th, at 3:30. The campus will also be illuminated in acknowledgment of TRC from September 28th to the 30th. At the College of Education, Husky Athletics will affiliate with the Truth and Reconciliation theme, with events on September 20th, 29th, and 30th. Lastly, a related event is slated for September 13th, and volunteers are sought for many of these activities.

Feel free to join us and dedicate some time to our cause. You're welcome to participate as a volunteer. Detailed information about these events can be accessed on indigenoususas.ca. With all these engagements, September promises to be a bustling month. I'm eager to make the most of it and connect with as many of you as possible. Thank you.

She began by acknowledging the recent busyness due to powwows and various hiring committee activities. She then highlighted an important event in September, Truth, and Reconciliation Day. Q: Will the T-shirts be provided for free? R: They can be purchased at various locations, including the USASK shop, colleges, and Fire Creek, among others.

## Any Other Business/ Announcement

The president informed that there are T-shirts available for both students and GSA executives. Council members are encouraged to share this information widely, and a general announcement will also be made.

# President proposed 2 ideas.

The President proposed the establishment of a notice board exclusively dedicated to graduate students. This platform would facilitate the sharing of essential information such as accommodation options and other pertinent matters. He cited the University of Waterloo's successful implementation of a similar notice board and emphasized its potential benefits. The President assured that incorporating this feature into the graduate hub on our website would incur no additional cost.

The second suggestion put forth was to create opportunities for graduate students to engage in babysitting services, thereby generating employment within our student community. While acknowledging the existence of other babysitting applications, the President noted their associated costs. By integrating this service into our website, graduate students could secure part-time positions in both residential and event settings. Additionally, individuals possessing relevant qualifications or certificates would be eligible to participate. This initiative holds the potential to serve as a revenue-generating venture for both the GSA and our student body.

• The recording secretary submitted that it is a great idea, and he thinks should be acted on faster to create job opportunities for our students as well as a source of revenue for GSA.

Sara asked when the ratification of new associations would be done.

President answered that it would be communicated in our emails and that the association should do their homework because ratification is ongoing.

## The chairperson responded that they don't need to do anything for ratification.

The GSA president informed council members that the GSA Executive election procedure is posted on the GSA website, so members are encouraged to visit the website for any information. The next council meeting information will be sent.

# 2. Meting with USASK president Peter Stoicheff, Vice-Provost of Teaching and Learning, and Vice-President University Relation:

President Mostofa Kamal proposed to meet all the University VPs to meet and discuss about the GSA concerns and our needs. Due to time shortage on every PEC meeting, the GSA needs to talk with university leaders to share the GSA updates.




